



**AN ACT TO ADD NEW §§ 6215 AND 6215.1 TO
ARTICLE 2, CHAPTER 6, TITLE 4, GUAM CODE
ANNOTATED, RELATIVE TO PREVENTING THE
WAIVER OF THE PUBLIC HEARING REQUIREMENT
FOR BILLS PROPOSING SALARY CHANGES FOR
ELECTED OFFICIALS; AND TO REQUIRING THAT
ANY CHANGE IN SALARY OF ELECTED OFFICIALS
TAKE EFFECT AFTER A GENERAL ELECTION TO
THE GUAM LEGISLATURE HAS INTERVENED.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Public Hearing for Salary Changes for Elected Officials**

3 **May Not Be Waived.** A new § 6215 is hereby *added* to Article 2, Chapter 6, Title

4 4, Guam Code Annotated, to read:

1 **“§ 6215. Public Hearing for Salary Changes for Elected**
2 **Officials May Not Be Waived.**

3 The public hearing required under § 2103(a) of Chapter 2, Title 2,
4 Guam Code Annotated, may *not* be waived for any reason for a bill
5 introduced in the Guam Legislature to vary the compensation of the
6 Governor, Lieutenant Governor, or Senators of the Guam Legislature.”

7 **Section 2. Effective Date for Salary Changes for Elected Officials.** A
8 new § 6215.1 is hereby *added* to Article 2, Chapter 6, Title 4, Guam Code
9 Annotated, to read:

10 **“§ 6215.1. Effective Date for Salary Changes for Elected**
11 **Officials.**

12 No law varying the compensation for the services of the Governor of
13 Guam, the Lieutenant Governor of Guam, and/or Senators of the Guam
14 Legislature shall take effect, until a General Election for the Guam
15 Legislature shall have intervened.”

16 **Section 3. Severability.** If any provision of this Law or its application to
17 any person or circumstance is found to be invalid, or contrary to law, such
18 invalidity *shall not* affect other provisions or applications of this Law which can be
19 given effect without the invalid provision or application, and to this end the
20 provisions of this Act are severable.
