#### BE IT RESOLVED BY KONSEHELON MAHOT GUÅHAN:

WHEREAS, the late Honorable Agustin "Dinga" Guzman Quintanilla was born on August 8<sup>th</sup>, 1962 in the village of Agat and was called "home' by his Creator on March 19, 2015; and

WHEREAS, the late Honorable Agustin "Dinga" Guzman Quintanilla is the son of the late Jesus Taitano and the late Remedios Guzman Quintanilla; and

**WHEREAS**, upon his graduation from the Guam Community College in Mangilao he became employed at the U.S. Navy Guam Ship Repair Facility; the U.S. Navy Public Works Center as a welder; and later as a structural leader for Raytheon and a combination welder for DZSP; and

WHEREAS, upon the untimely passing of the late Honorable Vice Mayor Jesus B. Chaco, the late Honorable Agustin Guzman Quintanilla was appointed by Governor Felix P. Camacho in November 2009 to serve his remaining term as the Vice Mayor of Agat; and

**WHEREAS,** in 2010 the late Honorable Agustin Guzman Quintanilla was successful in his bid and became the 13<sup>th</sup> elected Vice Mayor of Agat; a capacity he served in for five years; and

WHEREAS, the late Honorable Agustin Guzman Quintanilla was active in the community as a member of the Agat Municipal Planning Council (1996-present); vice president of the Agat Santa Ana Rancheros Association (2004-present); a member & vice president of the Marcial Sablan Elementary School PTA (2005-2006); manager for the Agat Cardinals Baseball Team (1984-1995); a sponsor for the Agat Cardinals Baseball Team (2012-present); and a member of Western Visayas College of Science & Technology (WBCST) Association-Guam Chapter; and

WHEREAS, the late Honorable Agustin "Dinga" Guzman Quintanilla was active in his faith giving of his time and talent to the parishes of Mount Carmel and Santa Ana and during the village fiestas, parties and holiday events he was the person behind the scenes cooking, roasting and baking for the church and the community; he loved to do what he enjoyed and that is cooking and building utilizing natural resources; and

WHEREAS, the late Honorable Agustin "Dinga" Guzman Quintanilla personal achievements include his active participation in Operation Pacific Haven, Operation Tandem Thrust '99, the building of the Santa Ana Chapel under the Santa Ana Association, the building of the Sagan Bisita extended pavilion, the Agat village Liberations Floats; and

WHEREAS, the late Honorable Agustin "Dinga" Guzman Quintanilla was handy and talented with his hands fabricating benches for the Agat Gym, the Agat Baseball Field Dugout House, the Guam Liberation Carnival and many more; and in celebration of Guam's Chamorro Month and supporting our military sister-village, he fabricated Chamorro huts at the Main Navy Exchange, the Naval Station and the Agana McDonald's Restaurant. He constructed benches for the Agat gym and baseball field dugout house; and

WHEREAS, among his achievements, Vice Mayor "Dinga" Quintanilla received numerous awards and recognitions from Southern High School; Oceanview Middle School; Marcial Sablan Elementary School; Mount Carmel School; Notre Dame High School; and the Pacific Island Jurisdiction AIDS Action Group, Department of Public Health and Social Services; and

WHEREAS, during his tenure he was instrumental in numerous projects and events such as the Liberation Events, the Fena Memorial, the Halloween, Christmas and Easter events, the Agat Night Market, the Sagan Bisita Market, the Agat Mango Festival, the Compact Impact Phase 1 and Phase 2 Rehabilitation and Repair grants, the Island Wide Junk Collection and Removal program- *Na gas gas I tanota*, and was directly involved in the delivery of services to his constituents taking the time to listen, take action and follow up all of which became his lasting legacy; and

WHEREAS, the many community activities he was involved in earned praise from residents and visitors and loved to take part in Beautification Projects which showcased the wonderful talents of the people of Agat; and

**WHEREAS**, he knew and understood the people of his village and had a deep and abiding love for his neighbors and had given of himself over the five years he served in public office; he saw to their needs, cared for them and gave them the attention they deserved; and

**WHEREAS**, he had a wonderful warm sense of humor, a kindred spirit and instantly befriended you; and

WHEREAS, the late Honorable Agustin "Dinga" Guzman Quintanilla will be missed but never forgotten and his legacy lives on through his unselfish service to his island, and most especially in the memories of his constituents of Agat, the parish of Mt. Carmel and Santa Ana Chapel, his children Nakita and twins Alianna and Julianna, his siblings and their families, his colleagues, both past and present of the Mayors' Council of Guam; now, *therefore be it*

WHEREAS, the late Honorable Vicente Cepeda Bernardo was born on August, 21,
1930 in the Barrio de Santa Cruz, Hagåtña and was called "home' by his Creator on March
17, 2015; and

WHEREAS, the late Honorable Vicente Cepeda Bernardo is the son of the late
Concepcion Meno Cepeda (Familian Baliga/Lencho/Cocora) and the late Pedro Cruz
Bernardo (Familian Koho/Tagalo); and

8 WHEREAS, he and his family after the bombing of the Japanese settled in Asinan,
9 Pago Bay where his mother was laid to rest at their ranch during war in 1944 and after
10 WWII ended the Bernardo family resettled in Yona; and

WHEREAS, in 1950 he worked as a salesman for the Coca Cola Company and
traveled the island to the many mom and pop stores to deliver and to where he met his
future wife; and

WHEREAS, the late Honorable Vicente Cepeda Bernardo met and married Maria Taitano Cruz Bernardo (Familian Liberato/Lucas/Andai) on September 08, 1951 and were blessed with two (2) daughters, the late Irene and Linda; and further blessed with seven grandchildren, 15 great grandchildren and two great great grandchildren; and

18 WHEREAS, in 1957 the late Honorable Vicente Cepeda Bernardo and Maria 19 Taitano Cruz Bernardo opened a grocery store in the main village of Yona later re-opened 20 a bigger store in Camp Witek, Yona both donning the name the "Bernardo's Store" which 21 later expanded to include the sale of shoes, a barber shop, a feed store and a cockfight 22 dome; and WHEREAS, he would often meet and come upon families who struggled and were
 in need and would offer them free food and products and helped even if they could not
 afford all items but he gave from his heart; and

WHEREAS, the late Honorable Vicente Cepeda Bernardo worked both in public
and private enterprise over the years and was duly elected Commissioner of Yona in
November, 1972 and served as Commissioner/Mayor from January 8, 1973 until January
1, 2001 for a total of 28 years; and

8 WHEREAS, during his tenure he was instrumental and directly involved in the 9 naming of streets in honor of Yona's fallen military sons and those residents deserving of 10 the recognition, numerous village wide capital improvement projects such as street lights, 11 fire hydrants, water pump stations, water and sewer lines, land developments, the 12 building of the police koban, fire station, public health center, bus station, post office, the 13 village gymnasium, the village library, the manamko center in which he donated his own 14 private land and lot; Mayor Bernardo also improved relations with the military sister 15 squadrons for both Navy and Air Force and his community, developed the Tagachang 16 Beach park and numerous mini parks, cared about beautification, economics and assisted 17 in the Mangengon Hills developments, additionally he paved numerous roads all of 18 which became his lasting legacy; and

19 WHEREAS, the many, many community activities he spearheaded earned praise 20 from residents and visitors and one of his favorites was the infamous beautification 21 project in which they built a Carabao which was used for the Liberation Parade in 1980 22 and then remained parked by this office as a symbol as it represented hard work and 23 determination; the monument still stands this very day, a monument that he decorated annually with countless Christmas lights and other flora and fauna and have become a
 familiar attraction to residents, local and tourists; and

WHEREAS, he knew and understood the people of his village and had a deep and abiding love for his neighbors and had given of himself over the 28 years he served in public office; he saw to their needs, cared for them and gave them the attention they deserved; and

7 WHEREAS, as a model public servant he contributed far beyond the regular eight8 hour, five-day work-week; and

9 WHEREAS, the late Honorable Vicente Cepeda Bernardo will be missed but never 10 forgotten and his legacy lives on through his unselfish service to his island, and most 11 especially in the memories of his constituents of Yona, the parish of St. Francis, his wife 12 and children, grandchildren, great grandchildren and great great grand children, his 13 siblings and their families, his in-laws, his colleagues, both past and present of the 14 Mayors' Council of Guam; now, *therefore be it*
