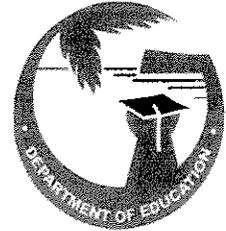

Audit Review – iLearn Academy Charter School Invoice Validation

For the period of March and April 2015

Purpose: To validate iLearn Academy Charter School’s invoices for the months of March (supplemental) and April, 2015.

Results: Pursuant to Public Law (P.L.) 32-219, upon receipt of invoices, Guam Department of Education (GDOE) shall verify invoices for accuracy and report its findings to the Department of Administration (DOA) within ten (10) business days. Internal Audit Office (IAO)’s review focused on validation of March and April expenditures. The results were as follows:

Total budget requested for March (supplemental) and April reimbursement was \$97,620.52 (see attachment 1). The classification of accounts provided by iLearn Academy Charter School listing were:

On March 30, 2015 IAO received iLearn Academy Charter School's March (supplemental) and April budget requests and invoices. Based on IAO's review, a total of \$133,775.04 was supported by invoices, inclusive of carryover invoices from IAO's prior March validation report. Carryover balances are remaining invoices not validated in the prior month due to iLearn submitting invoices which exceed the requested budget allotment per object class category. The IAO validated the amount of \$83,298 for the months of March and April leaving a variance of \$(36,154.52). **IAO recommends the release of \$83,298.** The remaining carry over balance of \$50,477.04 can be reimbursed in the next reporting period if iLearn includes the balance in its next budget request and DOA approves the allotment of funds.

"Section 2. Notwithstanding any provision of law for the School Year 2014-2015, pursuant to Title 17 GCA, Chapter 12, § 12116 (e), the Department of Administration (DOA) is hereby authorized and directed to deduct Five Thousand Five Hundred Dollars (\$5,500) per enrollee of Academy Charter Schools chartered by the Guam Academy Charter Schools Council, not to exceed six hundred (600) students for the Guahan Academy Charter School and three hundred fifty-eight (358) students for the iLearn Academy Charter School chartered by the Guam Academy Charter Schools Council during School Year 2014-2015, if any, as recommended by the Guam Academy Charter Schools Council, from the total General Fund appropriation in Section 1 of this Part of this Chapter to the GDOE, based on the actual enrollment at the time, multiplied by the per pupil cost, as established in this Section. Each Academy Charter School shall submit a monthly invoice to the DOA. Upon receipt of said invoice, the DOA shall remit it to the GDOE. Upon receipt of the remitted invoice, the GDOE shall verify the invoice for accuracy and report its findings within ten (10) days of receipt of said invoice to the DOA prior to the release of funds. If the GDOE fails to report its findings, the invoiced amount received by the DOA shall be automatically transmitted to each Academy Charter School."

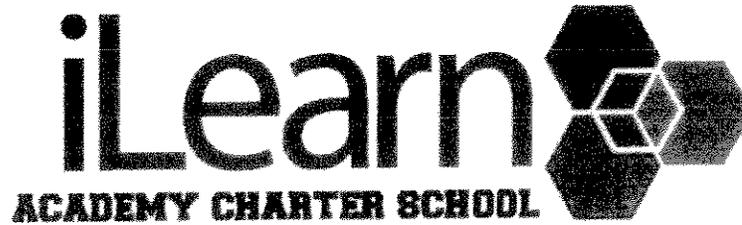

FOR MARCH VARIANCE

Per the IAO's recommendations, iLearn is requesting reimbursement of the March variance and including it in the April allotment request to DOA.

Attached is a duplicate copy of the March invoices submitted on 3/3/15 for your reference. **NOTE: Under Personnel Salaries, the amount is \$14,322.52 and total March variance should be \$35,297.52**

On March 3, 2015, iLearn submitted invoices totaling \$98,547.52 to GDOE. On March 4, 2015, DOA submitted iLearn's approved allotment request totaling \$63,250.00 to GDOE. The IAO cannot validate invoices of object class categories that were not approved by DOA. Therefore, the IAO only validates the invoices for the A+ Contract of \$83,215.00 and Extended Learning of \$1,000.00. The IAO recommends for iLearn to request reimbursement of the \$35,297.52 variance in its next allotment request to DOA. Refer to Table 2 for details.
