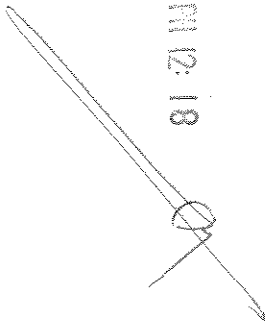

III. Approval of Minutes

IV. Reports

a. Management/Receiver's Report

i. Monthly Tonnage and Collections

Receiver, Chace Anderson, presented to the board the monthly Tonnage and collections report. He highlighted that there was a 3% increase in disposal for the Government of Guam, because of the bio solids. Elyze Iriarte inquired on why there is sometimes northern disposal being dropped off to Layon and southern disposal being brought to Guahan. Chace informed board of how the roll off route works.

a. Sub Committee Reports

Legal Counsel, Georgette Concepcion, presented a hard copy draft of the rules and regulations to the board for their review.

i. GSWA Board of Directors Rules and Regulations

Board members went through the draft together and informed Georgette of their suggestions and requests to make changes. Board member, Joseph Duenas, motioned to approve the rules and regulations subject to the corrections. Motion was seconded by Elyze Iriarte. Motion was carried.

ii. General Manager Search

Interim Chair, Andrew Gayle, asked that the subcommittee work with Georgette Concepcion and the receiver, Chace Anderson, in putting together the language for the General Manager search publication.

b. Contract Employees vs Permanent Employees

No decisions in regards to this. Joseph Duenas suggested they look into temporarily placing the existing employees into unclassified government positions until such time that the General Manager is hired, at which time the employees could be evaluated and placed into classified government positions.

c. Bill 30 re: Legal Counsel for Government of Guam Agencies

Elyze Iriarte, stated no update on the bill. She also stated that they have submitted the board's position statement.
