There will be an added focus on Compact Free Association (CFA) migrant populations together with military members, their families, and support personnel needs will continue to be ongoing efforts of Guam's projects. These services are to include short-term shelter, referral services, special units, safe visitation/exchange for children, outreach prevention services projects, sub-grantee cross training, support personnel staff training, government wide and other workplace training, referral and support services, government and NGO advocacy, faith and community based services for the unserved, inadequately served, underserved and special needs populations such as the elderly and persons with special needs, to include immigration matters, data collection, and centralized coordinated services, etc. These funds will also go towards personnel, travel for seven, supplies, and contractual fees.
