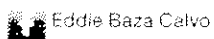





**AN ACT TO *AMEND* § 1515(i)(2)(G) OF ARTICLE 5,
CHAPTER 1 OF TITLE 5, GUAM CODE ANNOTATED,
RELATIVE TO EXTENDING THE DEADLINE FROM
JULY 31, 2015 TO MARCH 31, 2016, FOR THE GUAM
FISHERMEN'S COOPERATIVE ASSOCIATION TO
EXPEND OR ENCUMBER THE PROCEEDS OF THE
GRANT FOR THE CONSTRUCTION, REPAIR AND
IMPROVEMENTS OF THE GUAM FISHERMEN'S
COOPERATIVE ASSOCIATION FACILITY.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** § 1515(i)(2)(G) of Article 5, Chapter 2 of Title 5, Guam Code
3 Annotated, is hereby *amended* to read:

1 “(G) for purposes of issuing a grant of no more than Five Million
2 Dollars (\$5,000,000) to the Guam Fishermen’s Cooperative Association
3 (GFCA) for the purposes of construction, repair and improvements of its
4 facility as part of the Greg D. Perez Marina Economic Enhancement Master
5 Plan.

6 No funds authorized in this Section shall be used to pay the Guam
7 Economic Development Authority or its contracted consultants.

8 Notwithstanding the order of priority requirement in § 1515(i)(2) and
9 upon enactment, the sum of Two Million Dollars (\$2,000,000) of the
10 proceeds are authorized, appropriated and *shall* be deposited and accounted
11 for in a separate trustee sub-account for the payments of expenses associated
12 with the construction, repair and improvements of the GFCA facility. Any
13 services or contracts or expenses associated with the construction, repair and
14 improvements of the GFCA facility under this grant *shall* require the
15 approval of the GFCA. Disbursements for payments of expenses associated
16 with the construction, repair and improvements of the GFCA facility *shall*
17 be approved by the GFCA and countersigned by GEDA. The proceeds of the
18 grant must be expended or encumbered by the GFCA for the purposes
19 provided herein no later than March 31, 2016. *If* any funds authorized by this
20 Section remain unexpended or unencumbered after March 31, 2016, the
21 amount of the unencumbered or unexpended authorization *shall* be subject
22 to legislative re-appropriation. Funds not authorized for expenditure by the
23 GFCA in this Section are subject to legislative appropriation for tourism-
24 related capital improvement projects. The GFCA *shall* report to *I Maga’lahi*
25 (the Governor) and the Speaker of *I Liheslatura* (the Legislature) on a
26 quarterly basis of all expenditures of this grant and other funds secured by
27 the GFCA used for the construction, repair and improvements of its facility

1 until the grant is fully expended and the facility construction, repair and
2 improvements are completed.”
