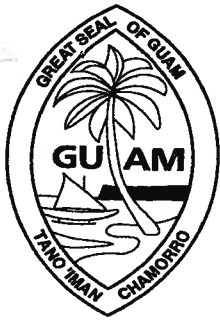



Upon a motion made by Vice Chairman Pinauin and seconded by Commissioner Pangelinan the Commissioners adjourned at approximately 8:23 pm.


