


CERTIFICATION OF PASSAGE OF AN ACT TO *I MAGA'LÁHEN GUÁHAN*



AN ACT TO ADD A NEW § 832.1 TO ARTICLE 1, CHAPTER 8, TITLE 1, GUAM CODE ANNOTATED; AND TO REPEAL § 79601.2 OF ARTICLE 6 OF CHAPTER 79, TITLE 21, GUAM CODE ANNOTATED, AS ENACTED BY PUBLIC LAW 32-046, RELATIVE TO THE ESTABLISHMENT OF A WAR ON TERROR FALLEN HEROES MONUMENT ON THE ADELUP PARADE FIELD OF THE RICARDO J. BORDALLO GOVERNOR'S COMPLEX AT ADELUP.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 that Public Law 32-046 was signed into law on July 5, 2013, authorizing the Fallen

1 Heroes of the Pacific Foundation (Guam) to erect a memorial monument at
2 Skinner Plaza in *Hagåtña*.

3 *I Liheslaturan Guåhan* further finds that the Fallen Heroes of the Pacific
4 Foundation (Guam) has requested to relocate the monument from the Skinner
5 Plaza to the Adelup Parade Field of the Ricardo J. Bordallo Governor’s Complex
6 at Adelup to memorialize and pay tribute to the men and women who have made
7 the ultimate sacrifice; and to provide a place of solemnity and contemplation for
8 everyone.

9 Therefore, it is the intent of *I Liheslaturan Guåhan* to relocate the War on
10 Terror Fallen Heroes Monument from the Skinner Plaza to the Adelup Parade
11 Field of the Ricardo J. Bordallo Governor’s Complex at Adelup by adding a new §
12 832.1 to Article 1, Chapter 8, Title 1, Guam Code Annotated; and by repealing §
13 79601.2 of Article 6 of Chapter 79, Title 21, Guam Code Annotated, as enacted by
14 Public Law 32-046.

15 **Section 2.** A new § 832.1 is hereby *added* to Article 1 of Chapter 8, Title
16 1, Guam Code Annotated, to read as follows:

17 **“§ 832.1. War on Terror Fallen Heroes Monument.**

18 Notwithstanding any other provision of law, the Fallen Heroes of the Pacific
19 Foundation (Guam) is hereby authorized to erect a memorial monument on
20 the Adelup Parade Field of the Ricardo J. Bordallo Governor’s Complex at
21 Adelup, in honor of Guam’s men and women of the U.S. Armed Forces who
22 have courageously and selflessly served our island and our nation, and who
23 have made the ultimate sacrifice in the War on Terror, to include Operation
24 Iraqi Freedom and Operation Enduring Freedom.

25 The Fallen Heroes of the Pacific Foundation in the preparation and
26 construction of the War on Terror Fallen Heroes Monument *shall* comply
27 with the following provisions:

1 (a) occupy a land space *not to exceed* more than twenty feet
2 (20') in length and twenty feet (20') in width within the Ricardo J.
3 Bordallo Governor's Complex at Adelup;

4 (b) submit to the Office of the Governor the plan and design
5 of the monument for approval by Executive Order. The monument
6 *shall* include, at a minimum and as provided for in this Chapter, the
7 names of Guam's fallen heroes and the branch served in the U.S.
8 Armed Forces; and

9 (c) *shall not* hold the government of Guam liable or
10 responsible for any expenses related to the construction and
11 maintenance of the monument authorized herein.”

12 **Section 3.** § 79601.2 of Article 6 of Chapter 79, Title 21, Guam Code
13 Annotated, as enacted by Public Law 32-046, is hereby *repealed*.
