**AN ACT TO ADD A NEW § 7120.4 TO CHAPTER 7,  
TITLE 16, GUAM CODE ANNOTATED, RELATIVE TO  
FIREFIGHTER LICENSE PLATES.**

1       **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2       **Section 1.** A new § 7120.4 is hereby *added* to Chapter 7 of Title 16, Guam  
3 Code Annotated, to read as follows:

4               **“§ 7120.4. Firefighter License Plates.**

5               (a) The purpose of this Section is to provide license plates  
6 recognizing firefighters who reside on Guam.

1 (b) Definition. *Firefighter* means any person who is currently  
2 employed as a firefighter with the government of Guam or the United States  
3 government, or any person who has retired from said service. Any person  
4 who was terminated for cause as a firefighter *shall not* be eligible.

5 (c) Application. Any person who is a firefighter, as evidenced by a  
6 personnel action or other similar document, and is the registered owner or  
7 lessee of a passenger vehicle registered with the Department of Revenue and  
8 Taxation, or who makes an application for an original registration or renewal  
9 registration of any such vehicle, may apply to the Motor Vehicle Division of  
10 the Department of Revenue and Taxation for a firefighter license plate which  
11 *shall* be affixed to the passenger vehicle for which registration is sought in  
12 lieu of regular license plates.

13 (d) Color and Design. A firefighter license plate *shall* be the same  
14 standard size and shape as a regular passenger vehicle license plate. The type  
15 and style of the firefighter license plates *shall* be determined by the Director  
16 of the Department of Revenue and Taxation and the Chief of the Guam Fire  
17 Department.

18 (e) Fee. The fee for the issuance of a firefighter license plate(s)  
19 *shall not* exceed the fee charged for a similar license plate for the same class  
20 of vehicle, and no such fees shall be subsidized by the government.

21 (f) Issuance. A firefighter license plate(s) *shall* be issued *only* to  
22 the registered owner or lessee of the vehicle on which they are to be  
23 displayed. Registration for a firefighter license plate(s) *shall* be limited to  
24 two (2) vehicles per firefighter.”

25 **Section 2. Effective Date.** This Act *shall* be effective upon enactment.
