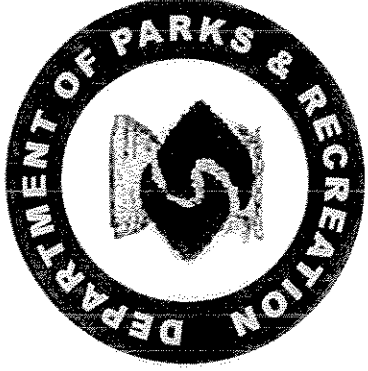


WHEREAS, the Parks and Recreation Commission is to advise the Director on such matters relative to the Department as he shall bring before it, at meeting called by him; and


