



### Alee 2 Children's Home

### October 2015

This month we served a total of thirteen (13) children; twelve (12) Chamorro and one (1) Chuukese. All children here at the shelter are placed by Child Protective Services (CPS). The shelter continues to provide Personal Care, Teaching Life Skills, Transportation and Recreational Outings for all of the children.

On October 05, 2015 the shelter received a ten (10) year old Chuukese boy. This minor is wheelchair bound. On minors first couple of days here at shelter he cried and expressed that he really misses his siblings. Since placement minor has adjusted to the shelter. Minor had one (1) visit with his siblings this month. Minor returned from visit visibly upset and expressed that he missed his siblings. Minor is adjusting well to being in the shelter however needs to be reminded that although he is very independent he still needs to have staff present when transferring in and out of his wheelchair. Minor was transferred to Tamuning Elementary School on October 13, 2015 and as per his teacher, he is adjusting well. Minor has had one (1) home visit from His CPS Case Worker Norma Roberto and Guam Legal Services and Disability Law Corporation (GLS) Advocate Naomi Sanchez.

On October 8<sup>th</sup> shelter received a call from Arlene Gadia (CPS Supervisor) about placement for a nine (9) year old Chamorro girl. Minor attends school at Astumbo Elementary and is currently in the 3<sup>rd</sup> grade.

Minor has adjusted well to the rules and routines of the shelter and gets along well with both staff and other children. Minor has had no contact with family.

On October 5<sup>th</sup> the family of two (2) boys; ages nine (9) and six (6) year were transitioned to the Godmother of one of the boys. Prior to the placement, the boys had a weekend furlough with her. The visit went well and the transition took place the following week. A couple of weeks after placement, the Godmother called the shelter and shared that she was having behavioral issues with the older of the boys. She was instructed to speak with their CPS Case Worker Mari Blas for

A ten (10) year old Chuukese boy remains in the shelter. The minor had one (1) visit this month with his siblings at the office of Child Protective Service with a Homemaker supervising the visit. Minor is doing well. He continues to attend school at Tamuning Elementary. This month minor was chosen to perform a solo for his school's Thanksgiving Program. Program Manager was in attendance. Minor enjoys dancing, singing and playing with the other children. Minor has adjusted well to the rules and routines of the shelter.

A nine (9) year old Chamorro girl continues to reside in the shelter. Minor has not had any contact with family members. Minor did have an interview with the Guam Police Department on November 10, 2015 at the office of Child Protective Service in regards to her case. She continues to attend school at Astumbo Elementary and is doing well. Minor gets along great with the other children. A visit with her mother was scheduled but subsequently cancelled as per
