



**AN ACT TO AMEND SECTIONS 2 AND 3 OF PUBLIC  
LAW 33-01, RELATIVE TO AUTHORIZING THE  
ATTORNEY GENERAL THE USE OF FUNDS FOR  
EXPERTS IN FEDERAL LITIGATION CASES.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** Section 2 of Public Law 33-01 is *amended* to read:

3 **“Section 2. Carryover of FY 2014 Appropriations for the Office**  
4 **of the Attorney General.** Notwithstanding any provision of law, the  
5 unexpended balance of appropriations from the General Fund to the Office  
6 of the Attorney General for its operations in Fiscal Year 2014 *shall not* lapse  
7 and *shall* carry over into Fiscal Year 2016. Such funds *shall* only be

1 expended up to Seven Hundred Thousand Dollars (\$700,000) for the  
2 purposes described in Section 3 of this Act.”

3 **Section 2.** Section 3 of Public Law 33-01 is *amended* to read:

4 “**Section 3. Authority of the Attorney General to Procure**  
5 **Experts.** Notwithstanding any other provision of law, the Attorney General  
6 is authorized to procure litigation experts, on a sole source basis, to bring  
7 closure to Civil Case No. 91-00020, and other United States District Court  
8 of Guam cases in which the government of Guam is involved. No  
9 government funds *except* those appropriations described in Section 2 of this  
10 Act may be expended for this purpose.”

11 **Section 3.** This Act *shall* be read consistently with Public Law 33-66 to  
12 achieve the purposes stated herein.
