
CERTIFICATION OF PASSAGE OF AN ACT TO *I MAGA'LÅHEN GUÅHAN*

AN ACT TO APPROPRIATE ONE MILLION ONE HUNDRED SEVENTY FIVE THOUSAND DOLLARS (\$1,175,000) FROM THE UNRESERVED FUND BALANCE OF THE HEALTHY FUTURES FUND, AS OF SEPTEMBER 30, 2015, TO THE GUAM MEMORIAL HOSPITAL AUTHORITY (GMHA) FOR THE PAYMENT OF GMHA OUTSTANDING GUAM POWER AUTHORITY AND GUAM WATERWORKS AUTHORITY OBLIGATIONS.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Appropriation for Guam Memorial Hospital Authority**
3 **Utilities.** Notwithstanding the provisions of Chapter 26, § 26602(d) Title 11,
4 Guam Code Annotated, the sum of One Million One Hundred Seventy-Five

1 Thosuang Dollars (**\$1,175,000**) is appropriated from the unreserved surplus of the
2 Healthy Futures Fund, as of September 30, 2015, to the Guam Memorial Hospital
3 Authority (GMHA) for the *sole* purpose of funding outstanding Guam Power
4 Authority (GPA) and Guam Waterworks Authority (GWA) utility obligations.
5 Notwithstanding any other provision of law, the Director of Administration *shall*
6 remit the funds appropriated herein directly to the GPA and GWA as payment on
7 behalf of the GMHA *not later than* three (3) calendar days after the enactment of
8 this Act and *shall* report such payment to the Speaker of *I Liheslaturan Guåhan*
9 and *I Maga'låhen Guåhan* *not later than* one (1) day after such payment is made.
10 Notwithstanding any other provision of law, this appropriation *shall* continue to be
11 available until fully expended and is *not* subject to transfer or use for any other
12 purpose.

13 **Section 2. Effective Date.** This Act *shall* become effective upon
14 enactment.

15 **Section 3. Severability.** *If* any provision of this Act or its application to
16 any person or circumstance is held invalid, the invalidity *shall not* affect other
17 provisions or applications of this Act that can be given effect without the invalid
18 provision or application and to this end the provisions of this Act is severable.
