1.0. CALL TO ORDER / ROLL CALL

The meeting was called to order by Chairman Michael Makio at 3:10 p.m., and roll call was conducted.

2.0 ELECTION OF OFFICERS

Chairman Makio noted the by-laws of the Trust states the Chairman elected for the Historic Review Board will also serve as the Chair of the Trust.

 With no objection, the application was referred to the Grants Committee for review and recommendation to the Board.

Action **4.2. Before We Began Counting Years – Fr. Francis X. Hezel**
 Joe Quinata reported a grant application was submitted by Fr. Francis Hezel to fund \$108,343.00 for a video production of pre-history Guam.
 With no objection, the application was referred to the Grants Committee for review and recommendation to the Board.

Joe Quinata reported the current fund is \$5.1 million with a total of \$1.1 million available for grants and projects.

The bid opening of three homes in the historic district of Inalahan is scheduled for December 11.

The Board discussed the Memorandum of Understanding on the Manuel Guerrero building and current legislation being routed to re-appropriate the unused balance for the repairs of the Umatac Bridge.

Chairman Makio requested Legal Counsel Terrence Brooks to review the law and the Legislature's authority to utilize funds released to the Trust.

Joe Quinata will provide Legal Counsel with a copy of the law.


7.0. ADJOURNMENT

There being no further business, Dave Lotz motioned to adjourn the meeting.



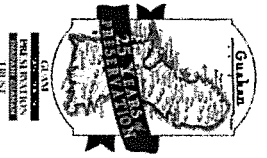
