- Enforce practice requirements

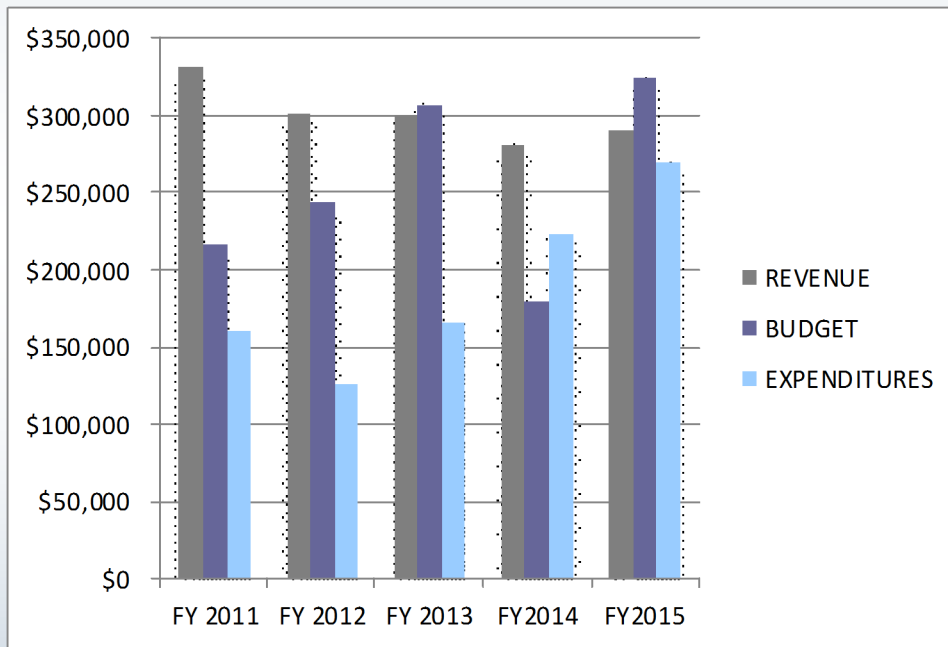

# FINANCIAL DATA:

The Board's main sources of revenue are fees for the issuance and renewal of registrations and fees for application from individuals wish to take the engineering, architecture and land surveying examinations, and for applicants seeking registration by comity. These fees support the registration, examination, enforcement and administration programs, which includes processing and issuing registrations, statues, rules and regulations, and printing and distributing rosters, and general operating expenses.
