AN ACT TO AMEND SECTION 651.2 OF THE CIVIL
CODE OF GUAM TO REQUIRE THAT THE ANNUAL
REPORT OF A NON-PROFIT ORGANIZATION BE
FILED WITHIN NINETY DAYS OF THE CLOSING
OF ITS FISCAL YEAR.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. Section 651.2 of the Civil Code of Guam is
3 hereby amended to read as follows:

4 "Section 651.2. Filing of Annual Reports. Except
5 for an organization that is entirely religious in
6 character, ^{any} every non-profit organization, including but
7 not limited to a fraternal benefit society, order or
8 association operating under the lodge system, a corpora-
9 tion, association or society organized and operated for
10 eleemosynary, scientific or educational purposes, business
11 league, Chamber of Commerce, ^c civil league, and an
12 organization operating for the benefit of the community
13 and for the promotion of social welfare, (shall caused to
14 be published annually within ninety days of the close of
15 its fiscal year in a newspaper of general circulation in
16 the territory of Guam) a financial report which report
17 shall include a statement of its income and expenditures
18 for the preceding year and a balance sheet showing its
19 assets and liabilities. Such financial statement: shall
20 contain a certificate as to its accuracy by ^{sub account} (an officer of
21 the organization, which financial statement shall be filed
22 with the Director of Revenue and Taxation.") ^{added}

23 Section 2. This Act is an urgency measure.
