AN ACT MAKING SUPPLEMENTAL APPROPRIATIONS FOR THE OPERATIONS OF THE EXECUTIVE BRANCH OF THE GOVERNMENT OF GUAM FOR THE FISCAL YEAR ENDING JUNE 30, 1969 AND TO THE OFFICE OF THE GUAM'S WASHINGTON REPRESENTATIVE FOR CALENDAR YEAR ENDING DECEMBER 31, 1969.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. The following sums are hereby appropriated  
3 from any available funds in the Unappropriated Surplus of the  
4 General Fund to supplement prior appropriations for the fiscal  
5 year ending June 30, 1969.

Section 2. There is hereby appropriated from any available funds of the Unappropriated Surplus of the General Fund the sum of Five Thousand Dollars (\$5,000) to supplement prior appropriation for the office of the Guam's Washington Representative for the calendar year ending December 31, 1969.
