Introduced by J. L. Anderson

AN ACT TO ADD A NEW CHAPTER 14 TO
TITLE IX OF THE GOVERNMENT CODE OF
GUAM AUTHORIZING BONUSES FOR VETERANS
OF THE GUAM COMBAT PATROL OR THEIR
SURVIVORS, AND FOR OTHER PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. A new Chapter 14 is hereby added to Title IX
3 of the Government Code of Guam to read as follows:

4 "Chapter 14

5 Bonus for Veterans of Guam Combat Patrol

6 Section 8980. Creation of bonus. In recognition
7 of the services performed on behalf of the people of
8 Guam by the Guam Combat Patrol, which services have received
9 inadequate recognition from the United States government,
10 and little prior recognition from the government of Guam,
11 there are hereby authorized to be paid to each veteran
12 of the Guam Combat Patrol, or his survivor or survivors,
13 bonuses in the sum of \$2,500.

14 Section 8981. Eligibility for a bonus. The
15 Director of Public Safety shall prepare a list of all
16 bona fide veterans of the Guam Combat Patrol, which list
17 shall govern eligibility for bonuses authorized by this
18 Chapter. Each eligible veteran, or his survivor or
19 survivors, shall apply for such bonuses to the Director
20 of Public Safety, who upon satisfactory proof that such
21 applicants are veterans of the Guam Combat Patrol or are
22 such a bona fide veteran's survivor or survivors, shall
23 certify to the Treasurer of Guam the eligibility of such
24 applicants for such bonuses, and the Treasurer shall
25 thereupon pay such bonuses to such applicants.

Section 8982. Authorization for appropriation.

There are hereby authorized to be appropriated all sums necessary to pay the bonuses authorized by this Chapter."

Section 2. Chapter 12 of Title IX of the Government Code of Guam, added by Public Law 9-55, Ninth Guam Legislature, is hereby renumbered Chapter 13, and Section 8950 thru 8956 are hereby renumbered Section 8960 thru 8966.

Section 3. This Act is an urgency measure.
