AN ACT

An Act making appropriations for the operations of the Executive Branch of the government of Guam for the fiscal year ending June 30, 1970; to repeal Public Law 10-55, Tenth Guam Legislature, and Sections 3 and 4 of Public Law 10-64, Tenth Guam Legislature; to amend the appropriations made by Public Law 10-33, Tenth Guam Legislature; to supplement the appropriations made by Section 1 of Public Law 10-64, Tenth Guam Legislature, for the operations of the Island Courts of Guam; to add new Sections 4302 and 4304 to the Government Code of Guam, establishing a revolving fund for housing receipts and disbursements and a housing board and making appropriations therefor and for other purposes.

Be it enacted by the People of the Territory of Guam:

Section 1. The following sums are hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund for the fiscal year ending June 30, 1970 for the purposes set forth hereinafter:

Section 2. Public Law 10-55, Tenth Guam Legislature, and Sections 3 and 4 of Public Law 10-64, Tenth Guam Legislature, are hereby repealed. All expenditures and encumbrances made from the appropriations contained in said Public Law 10-55 shall be charged against the appropriations made for the same purposed by this Act.

Section 3. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Thirty Eight Thousand Fifty (\$38,050) Dollars to supplement the appropriation made by Section 1 of Public Law 10-64, Tenth Guam Legislature, for the operations of the Courts of Guam for the fiscal year ending June 30, 1970.

Section 4. The following sub-items set out in Item 1 of Section 1 of Public Law 10-33, Tenth Guam Legislature are hereby reduced by the amounts set out opposite the said sub-items:

"I.	A.	For Elementary Schools	\$ 96,912

Section 5. The following sub-items set out in Item 1 of Section 1 of Public Law 10-33, Tenth Guam Legislature are hereby increased by the amounts set out opposite the said sub-items:

University of Guam

"I. A. Off-Island Travel and Transportation \$301,200

B. Transportation Maintenance (P. W. Support) 1,380,354"

Section 6. The Department of Education and University of Guam are hereby authorized to spend over and above the appropriations made

by Section 4 of this Act any additional Federal grants for approved projects upon receipts of said grants.

Section 7. Any grant received from the United States as general fund revenue is authorized to be expended for the purpose or purposes for which made.

Section 8. Official or administrative travel appropriated for by Sections 1 and 4 of this Act are limited to the following sums:

Section 9. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Eight Hundred Thousand (\$800,000) Dollars to fund the amendments of the pay range schedule set out in Section 4103 of the Government Code of Guam made by Bill No. 359, passed by the Tenth Guam Legislature on July 8, 1969. The appropriated sums from said amount shall be distributed among the various programs set forth herein. The amount appropriated by this Section 8 of this Act shall revert to the Unappropriated Surplus of the General Fund should the Governor fail to approva Bill No. 359.

Section 10. Section 4302 is hereby added to the Government Code of Guam to read:

"Section 4302. Housing Revolving Fund. (a) There is hereby established a fund to be known as the 'Housing Revolving Fund'. This fund shall be maintained separate and apart from other funds of the government of Guam and independent records kept as to its use.

- (b) All moneys received from housing rentals shall be deposited with the Treasurer of Guam for credit to this fund.
- (c) All expenses of providing rental housing of whatever kind or nature shall be paid from this fund. These expenses shall be paid by the Treasurer of Guam upon vouchers properly certified to by the Director of Administration.
- (d) No expenditure may be made from this fund to provide rental housing for any person, other than the Governor of Guam, whose salary is not paid out of funds appropriated by the Legislature, it being the intention of this paragraph to prohibit the use of local funds to provide housing for those paid from Federal or other non-locally appropriated funds, with the sole exception of the Governor of Guam.
- (e) Annually, the Director of Administration, via the Governor, shall transmit to the Legislature a budget projecting proposed expenditures from and receipts of the fund."
- Section 11. Section 4303 is hereby added to the Government Code of Guam to read:
- "Section 4303. Housing Board. (a) There is hereby established a housing board to supervise the rental housing furnish by the government of Guam to employees and other authorized persons. This board shall have the power to investigate and supervise the quality and effectiveness of the rental housing furnished by the government of Guam. It shall make an annual report to the Governor setting forth its activities during the prior fiscal year and any recommendations for the next year.
- (b) The board shall be composed of five (5) members. The Director of Administration shall be the Chairman. The remaining four (4) members shall be appointed by the Governor with the advice and consent of the Legislature. Their terms of office shall be four (4) years, provided, however, that the term of office of the first board members shall be as follows: Two appointed for three years and two appointed for four years. Members may be removed only for cause."
- Section 12. Section 4304 is hereby added to the Government Code of Guam to read:
- "Section 4304. Housing Board Operation. (a) The duties of the housing board are (1) to review and approve prospective leases, lease cancellations and other relevant agreements, (2) establish monthly

- rental rates, (3) approve requests for housing assignments and review the action taken on these requests, (4) receive and investigate any complaints as to housing conditions, (5) review maintenance work being performed as to its sufficiency, and (6) accept such other duties related to rental housing as are assigned to it by the Governor.
- (b) The housing board shall meet not less than once a month at a time and place selected by the board. All meetings shall be public except when the board by a two-thirds vote makes a finding that it would be contrary to the public interest to open the meetings to the public. Reasonable public notice must be given of all meetings.
- (c) The housing board shall adopt such rules as are reasonably necessary to its operation pursuant to the provisions of the Administrative Adjudication Act.
- (d) All departments and agencies of the government of Guam shall provide supporting services when needed.
- (e) The housing board shall published in a local newspaper of general circulation the rental costs and subsidies made for each rental unit.
- (f) The Governor may by executive order amend the duties or operating procedures of the housing board if such amendments are not inconsistent with Section 4303 of this Title."
- Section 13. There is hereby appropriated from any available funds of the Unappropriated Surplus of the General Fund the sum of Five Hundred Thousand Dollars (\$500,000) to the 'Housing Revolving Fund'.
- Section 14. The Department of Public Safety shall staff the police substation in the village of Merizo twenty-four hours per day.
- Section 15. The digest of this prepared by the Committee on Finance and Taxation of the Legislature, is attached to this Act and is incorporated herein as a recital preceding the enactment clause for the purpose of assisting in the interpretation and implementation of this Act.
- Section 16. The Governor of Guam may transfer not to exceed five per cent (5%) of any item of appropriation made by Sections 1 and 4 of this Act, for the operation of any department, agency, or office of the Executive Branch operating under appropriated funds for the fiscal year ending June 30, 1970, to any other item of appropriation for the

operation of any department, agency, or office of the Executive Branch for the fiscal year ending June 30, 1970, but no item of appropriation shall be increased more than five percentum as a result of such transfer, provided, however, that no such transfer shall be made by the Governor without the prior approval in writing of the Committee on Finance and Taxation or its successor of the Legislature.

Section 17. This Act is an urgency measure.
