

AN ACT TO ADD SECTION 17052 TO THE GOVERN-MENT CODE OF GUAM TO ZONE AN AREA IN THE MUNICIPALITY OF DEDEDO FOR CHURCH AND CHURCH RELATED ACTIVITIES AND TO AMEND P.L. 9-192 TO REMOVE ONE PARCEL OF LAND FROM ITS OPERATION.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. Section 17052 is hereby added to the

Government Code of Guam to read as follows:

"Section 17052. Church Zone in Dededo. As an amendment to the Dededo Zoning Map, (Land Management Drawing No. E3-67S39) adopted by the Committee on Rules of the Guam Legislature pursuant to the provisions of Section 17050 of this title, the area in the municipality of Dededo, bounded by West Santa Monica Avenue to the north, Dolores Street to the east, and West San Antonio Avenue to the south and west, is hereby declared to be zoned for church and church-related activities."

Section 2. Subsection (a) of Section 2 of Public Law 9-192, Ninth Guam Legislature, is hereby amended to read as follows:

"(a) In the manner hereinafter set out, the Governor is authorized to enter into a contract or contracts with any person, partnership or corporation, for the construction and erection of residential houses for sale to the people of Guam on those parcels of government-owned land in the municipality of of Dededo described as Parcels 1, 4, and 5, as shown on Land Management Drawing No. E4-68S650, dated January 26, 1968."
