Committee on Rules, by request of the Governor in accordance with Section 6(b) of the Organic Act of Guam.

AN ACT TO AMEND SECTION 19590 AND TO ADD A NEW SUBSECTION 19593.0103 TO SUB-CHAPTER F OF CHAPTER 6, TITLE XX, GOVERNMENT CODE OF GUAM, RELATIVE TO THE LEVY OF THE TOBACCO.TAX ON UNTAXED PURCHASES.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. Section 19590 of Sub-chapter F of Chapter 6,

Title XX, Government Code of Guam, is hereby amended to read

as follows:

"Section 19590. Levy. There is hereby levied and shall be assessed and collected, upon every business engaged in the manufacture or production in Guam, or importation into Guam, of any tobacco products, in addition to all other applicable taxes, an excise tax to be measured by the application of the following rates against the tobacco products so manufactured, produced or brought into Guam as herein provided. Such excise tax shall also be levied upon, assessed and collected from every business purchasing tobacco products in Guam for resale if no tax had been paid upon said tobacco products as herein provided."

Section 2. A new Subsection 19593.0103 is hereby added to Sub-chapter F of Chapter 6, Title XX, Government Code of Guam,, to read as follows:

"Section 19593.0103. At the time of purchase for resale, if the tobacco tax has not hereto attached."

Section 3. This Act is an urgency measure.
