
CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR

AN ACT TO AMEND THE SECOND PARAGRAPH OF SECTION 4213 OF THE GOVERNMENT CODE OF GUAM TO REDUCE THE REQUIRED YEARS OF EMPLOYMENT WITH THE GOVERNMENT OF GUAM OF THOSE WHO WISH TO WITHDRAW FROM EMPLOYMENT BUT LEAVE THEIR RETIREMENT CONTRIBUTION IN THE RETIREMENT FUND FROM FIVE YEARS TO THREE YEARS.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. The second paragraph of Section 4213 of the  
3 Government Code of Guam is hereby amended to read as follows:

4 "Any member who withdraws after having completed at  
5 least three years total service shall have the option of  
6 leaving his contributions in the Fund and receiving a  
7 service retirement annuity upon attainment of the age of  
8 60 years without choice of any of the optional survivors'  
9 benefits hereinafter described."

10 Section 2. This Act is an urgency measure.
