




CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR





AN ACT MAKING APPROPRIATIONS TO COMPLETE
AND PROVIDE FACILITIES FOR A FOOTBALL
FIELD AT GEORGE WASHINGTON SENIOR HIGH
SCHOOL, FOR CONTRIBUTION TO THE SOUTH
PACIFIC CONFERENCE, FOR CONTRIBUTION TO
PACIFIC CONFERENCE OF LEGISLATORS, AND
FOR THE ANNUAL LEGISLATIVE CONFERENCE ON
CHILDREN AND YOUTH.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any avail-
3 able funds in the Unappropriated Surplus of the General Fund the
4 sum of Eighty Thousand Dollars (\$80,000) to provide for the con-
5 struction of bleachers, lights and bathrooms at, and otherwise
6 to complete, the football field at George Washington Senior
7 High School.

8 Section 2. There is hereby appropriated from any avail-
9 able sum in the Unappropriated Surplus of the General Fund the
10 sum of Five Thousand Dollars (\$5,000) for the contribution of
11 the territory of Guam to the South Pacific Conference pursuant
12 to Section 1 of Public Law 10-59, Tenth Guam Legislature.

13 Section 3. There is hereby appropriated from any avail-
14 able sum in the Unappropriated Surplus of the General Fund the
15 sum of Twenty-Five Thousand Dollars (\$25,000) for the contribu-
16 tion of the territory of Guam to the Pacific Conference of
17 Legislators.

18 Section 4. There is hereby appropriated from any avail-
19 able sum in the Unappropriated Surplus of the General Fund the
20 sum of Twenty Thousand Dollars (\$20,000) for the annual Legis-
21 lative Conference on Children and Youth.

22 Section 5. This Act is an urgency measure.
