Committee on Rules, by request of the Governor in accordance with Section 6(b) of the Organic Act of Guam.

AN ACT MAKING APPROPRIATIONS TO COMPLETE AND PROVIDE FACILITIES FOR A FOOTBALL FIELD AT GEORGE WASHINGTON SENIOR HIGH SCHOOL, FOR CONTRIBUTION TO THE SOUTH PACIFIC CONFERENCE, FOR CONTRIBUTION TO PACIFIC CONFERENCE OF LEGISLATORS, AND FOR THE ANNUAL LEGISLATIVE CONFERENCE ON CHILDREN AND YOUTH.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Eighty Thousand Dollars (\$80,000) to provide for the construction of bleachers, lights and bathrooms at, and otherwise to complete, the football field at George Washington Senior High School.

Section 2. There is hereby appropriated from any available sum in the Unappropriated Surplus of the General Fund the sum of Five Thousand Dollars (\$5,000) for the contribution of the territory of Guam to the South Pacific Conference pursuant to Section 1 of Public Law 10-59, Tenth Guam Legislature.

Section 3. There is hereby appropriated from any available sum in the Unappropriated Surplus of the General Fund the sum of Twenty-Five Thousand Dollars (\$25,000) for the contribution of the territory of Guam to the Pacific Conference of Legislators.

Section 4. There is hereby appropriated from any available sum in the Unappropriated Surplus of the General Fund the sum of Twenty Thousand Dollars (\$20,000) for the annual Legislative Conference on Children and Youth.

Section 5. This Act is an urgency measure.
