AN ACT TO AMEND SECTION 13505.1 OF THE GOVERNMENT CODE OF GUAM RELATIVE TO THE PUBLICATION OF GOVERNMENT REAL PROPERTY AVAILABLE FOR LEASE OR SALE.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM: Section 1. Section 13505.1 of the Government Code of Guam is hereby amended to read as follows:

"Section 13505.1. Property available for lease or sale. The Director, and other officials or agencies of the government of Guam authorized by law to sell or lease government real property, shall annually prepare and submit to the Governor an inventory of all such real property, including property in an authorized government subdivision, available for disposition by sale or by lease for a term which exceeds one year. Upon approval by the Governor such inventory shall be published during the month of January of each year in a newspaper of general circulation in the territory. Any deletions or additions in such inventory thereafter occurring during the year shall be published in like manner within thirty days after such deletions or additions are approved by the Governor. No application for lease or sale of real property shall be received except as to real property included in such published inventory and any sale or lease of government real property which is not included in such published inventory shall be void. No real property shall be included in such inventory which is needed by any department or agency of the government, or for any public use, including any projected future use."
