AN ACT MAKING A SUPPLEMENTAL APPROPRIATION TO PUBLIC LAW 9-122, NINTH GUAM LEGISLATURE, FOR THE CONSTRUCTION OF COMMISSIONER'S OFFICES IN THE MUNICIPALITIES OF AGANA HEIGHTS, CHALAN PAGO-ORDOT, TAMUNING AND UMATAC.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. The following sums are hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund for the purposes of supplementing the appropriation made by Section 1, I, A of Public Law 9-122, Ninth Guam Legislature:

A. For the construction of a Commissioner's

Office at the municipality of Agana Heights \$10,000

B. For the construction of a Commissioner's

Office at the municipality of Tamuning 10,000

C. For the construction of a Commissioner's

Office at the municipality of Chalan

D. For the construction of a Commissioner's

Office at the municipality of Umatac 10,000
