




CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR





AN ACT TO AMEND SECTIONS 11902 AND 11903  
OF THE GOVERNMENT CODE OF GUAM, RELATIVE  
TO THE COMPOSITION OF THE PRIZE COMMITTEE  
IN CHARGE OF THE ANNUAL LEGISLATIVE SCHOLASTIC PRIZES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. Section 11902 of the Government Code of Guam is  
3 hereby amended to read as follows:

4 "Section 11902. Prize Committee. There is hereby  
5 established the 'Prize Committee' on the annual legis-  
6 lative scholastic prizes as established in this Chapter.  
7 Such committee shall consist of five (5) members. The  
8 Chairman of the Committee on Education of the Legislature  
9 or his delegate shall serve as chairman, the four others  
10 to be appointed by the Speaker of the Legislature. The  
11 Prize Committee shall annually convene upon call of the  
12 chairman to determine the prizes and recipients thereof.  
13 the President of the University of Guam, the Director  
14 of Education, and the Superintendent of Catholic Schools  
15 shall serve ex officio as nonvoting members of the  
16 Committee and shall provide the Committee with assis-  
17 tance in the implementation of this Chapter."

18 Section 2. Section 11903 of the Government Code of Guam  
19 is hereby amended to read as follows:

20 "Section 11903. Prize Ceremony. The Prize Committee  
21 shall inform the Legislature of the prize winners, and,  
22 working in conjunction with the Legislature, shall  
23 annually hold an appropriate ceremony for the award of

1 such prizes. Such ceremony shall include appropriate  
2 honors for the occasion and at said ceremony each  
3 prize winner shall receive, in addition to the prize  
4 awarded, a suitable prize certificate, in a form  
5 approved by the Committee, and signed by the Speaker."

6 Section 3. This Act is an urgency measure.
