AN ACT MAKING AN APPROPRIATION TO CONSTRUCT A GRAVEL ROAD FROM THE VILLAGE OF UMATAC TO THE EXISTING WATER STORAGE TANK IN THE MUNI-CIPALITY OF UMATAC AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Fifteen Thousand Dollars (\$15,000) to construct a gravel road from the village of Umatac to the existing water storage tank in the municipality of Umatac and to erect a fence around said water storage tank.

Section 2. The fund appropriated by Section 1 of this Act shall revert to the General Fund upon the failure of the Governor to construct said road within one (1) year from the effective date of this Act.

Section 3. Public Law 10=169 of the Tenth Guam Legislature is hereby amended to add a new Section 8 to read as follows:

"Section 8. A portion of the appropriation made by

used to match grants under the National Institute of
