




AN ACT MAKING AN APPROPRIATION TO CONSTRUCT
A GRAVEL ROAD FROM THE VILLAGE OF UMATAC TO
THE EXISTING WATER STORAGE TANK IN THE MUNI-
CIPALITY OF UMATAC AND FOR OTHER PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any available
3 funds in the Unappropriated Surplus of the General Fund the sum
4 of Fifteen Thousand Dollars (\$15,000) to construct a gravel road
5 from the village of Umatac to the existing water storage tank in
6 the municipality of Umatac and to erect a fence around said water
7 storage tank.

8 Section 2. The fund appropriated by Section 1 of this Act
9 shall revert to the General Fund upon the failure of the Governor
10 to construct said road within one (1) year from the effective
11 date of this Act.

12 Section 3. Public Law 10-169 of the Tenth Guam Legislature
13 is hereby amended to add a new Section 8 to read as follows:

14 "Section 8. A portion of the appropriation made by
15 Item XI, Sub-section B, of Section 1 of this Act may be
16 used to match grants under the National Institute of

1 Mental Health for the operational expenses of
2 a mental health center on Guam and such grants
3 from the National Institute of Mental Health are
4 hereby appropriated for the purposes for which
5 such grants are made; provided the amounts
6 appropriated herein for the Division of Mental
7 Health shall not exceed \$495,000.00."

8 Section 4. This Act is an urgency measure.
