
CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR

AN ACT MAKING A SUPPLEMENTAL APPROPRIATION
FOR THE DIVISION OF VOCATIONAL REHABILITATION
OF THE DEPARTMENT OF EDUCATION.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any available
3 funds in the Unappropriated Surplus of the General Fund the sum
4 of One Hundred Seventy-Three Thousand Three Hundred Dollars
5 (\$173,300.00) consisting of One Hundred Forty-Two Thousand Dollars
6 (\$142,000.00) federal funds and Thirty-One Thousand Three Hundred
7 Dollars (\$31,300.00) local matching funds under the Federal
8 Vocational Rehabilitation Act for the purpose of supplementing the
9 appropriation made by Section 1, I A 6 of Public Law 10-144, Tenth
10 Guam Legislature, to the Division of Vocational Rehabilitation
11 of the Department of Education.

12 Section 2. This Act is an urgency measure.
