AN ACT TO AMEND SECTION 1(VIII)B OF PUBLIC
LAW 10-171, TENTH GUAM LEGISLATURE INCREASING
THE AMOUNT OF AUTHORIZED APPROPRIATION TO
\$85,000 FOR WATERLINE AND FIRE HYDRANTS TO
SAN ANTONIO AND LALO AREAS OF BARRIGADA AND
ALONG THE AREA OF THE INALADO ROAD IN CHALAN
PAGO.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. Section 1(VIII)B of Public Law 10-171, Tenth
3 Guam Legislature, is hereby amended to read as follows:

6 B. Extension of waterline and necessary
7 fire hydrant to the San Antonio and Lalo areas,
8 municipality of Barrigada and to the East and
9 West respectively of Barrigada Junior High
10 School and along the area of Inalado Road in
11 Chalan Pago \$85,000."

12 Section 2. This Act is an urgency measure.
