



CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR


This is to certify that Bill No. 222, "An Act making an appropriation for the construction of steel guard rails at two sites in Inarajan and making supplemental appropriation for the completion of construction of the Inalado Road connecting Pago Bay to Route 10", which was heretofore passed and thereafter on May 8, 1971, returned to the Legislature without the approval of the Governor was, in accordance with the Organic Act of Guam, reconsidered by the Legislature and after such reconsideration the Legislature did on the 12th day of May, 1971, agree to pass said bill notwithstanding the objections of the Governor by a vote of more than two-thirds of all the members thereof, to wit: by a vote of 15 members.

AN ACT MAKING AN APPROPRIATION FOR THE CONSTRUCTION OF STEEL GUARD RAILS AT TWO SITES IN INARAJAN AND MAKING SUPPLEMENTAL APPROPRIATION FOR THE COMPLETION OF CONSTRUCTION OF THE INALADO ROAD CONNECTING PAGO BAY TO ROUTE 10.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any available  
3 funds in the Unappropriated Surplus of the General Fund the sum  
4 of Five Thousand Dollars (\$5,000) to construct steel guard rails  
5 at the Old Dump to the north of the Malojloj Well Road in the  
6 municipality of Inarajan.

7 Section 2. There is hereby appropriated from any available  
8 funds in the Unappropriated Surplus of the General Fund the sum  
9 of Fifteen Thousand Dollars (\$15,000) to construct steel guard  
10 rails at the Atkiya Hill Road in the municipality of Inarajan.

11 Section 3. There is hereby appropriated from any available  
12 funds in the Unappropriated Surplus of the General Fund the sum  
13 of Fifty Thousand Dollars (\$50,000) to supplement the previous  
14 appropriation made by Section 1 of Public Law 10-88, Tenth Guam  
15 Legislature for the construction of a public road along the  
16 right-of-way known as the Inalado Road so as to connect Pago Bay  
17 to Route 10.

18 Section 4. This Act is an urgency measure.
