AN ACT MAKING AN APPROPRIATION FOR THE CONSTRUCTION OF STEEL GUARD RAILS AT TWO SITES IN INARAJAN AND MAKING SUPPLEMENTAL APPROPRIATION FOR THE COMPLETION OF CONSTRUCTION OF THE INALADO ROAD CONNECTING PAGO BAY TO ROUTE 10.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Five Thousand Dollars (\$5,000) to construct steel guard rails at the Old Dump to the north of the Malojloj Well Road in the municipality of Inarajan.

Section 2. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Fifteen Thousand Dollars (\$15,000) to construct steel guard rails at the Atkiya Hill Road in the municipality of Inarajan.

Section 3. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Fifty Thousand Dollars (\$50,000) to supplement the previous appropriation made by Section 1 of Public Law 10-88, Tenth Guam Legislature for the construction of a public road along the right-of-way known as the Inalado Road so as to connect Pago Bay to Route 10.

Section 4. This Act is an urgency measure.
