



CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR





AN ACT MAKING AN APPROPRIATION FOR THE
OPERATION OF THE COMMUNITY ACTION AGENCY
OF THE EXECUTIVE BRANCH OF THE GOVERNMENT
OF GUAM FOR THE CALENDAR YEAR ENDING
DECEMBER 31, 1971.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any available
3 balance in the Unappropriated Surplus of the General Fund the
4 sum of One Hundred Seventy-Six Thousand, Ninety-Three Dollars
5 (\$176,093) for the operation of the Community Action Agency for
6 the calendar year ending December 31, 1971.

7 Section 2. Eighty-Eight Thousand Dollars (\$88,000) of the
8 appropriation made by Section 1 of this Act shall take effect
9 upon approval hereof.

10 Section 3. Eighty-Eight Thousand, Ninety-Three Dollars
11 (\$88,093) of the appropriation made by Section 1 of this Act
12 shall take effect July 1, 1971.

13 Section 4. The Community Action Agency is hereby authorized
14 to expend Federal funds over and above the appropriation made by
15 this Act for approved projects; provided, that no additional
16 local funds are required; and provided, further, that such grants
17 are not appropriated under Section 1 of this Act.

18 Section 5. The unencumbered balance for the operation of
19 the Community Action Agency for fiscal year ending June 30, 1971,
20 in the amount of \$24,246 (as of March 31, 1971) is hereby re-
21 appropriated to the Unappropriated Surplus of the General Fund.
