AN ACT MAKING AN APPROPRIATION FOR THE OPERATION OF THE COMMUNITY ACTION AGENCY OF THE EXECUTIVE BRANCH OF THE GOVERNMENT OF GUAM FOR THE CALENDAR YEAR ENDING DECEMBER 31, 1971.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM: Section 1. There is hereby appropriated from any available balance in the Unappropriated Surplus of the General Fund the sum of One Hundred Seventy-Six Thousand, Ninety-Three Dollars (\$176,093) for the operation of the Community Action Agency for the calendar year ending December 31, 1971.

Section 2. Eighty-Eight Thousand Dollars (\$88,000) of the appropriation made by Section 1 of this Act shall take effect upon approval hereof.

Section 3. Eighty-Eight Thousand, Ninety-Three Dollars (\$88,093) of the appropriation made by Section 1 of this Act shall take effect July 1, 1971.

Section 4. The Community Action Agency is hereby authorized to expend Federal funds over and above the appropriation made by this Act for approved projects; provided, that no additional local funds are required; and provided, further, that such grants are not appropriated under Section 1 of this Act.

Section 5. The unencumbered balance for the operation of the Community Action Agency for fiscal year endirg June 30, 1971, in the amount of \$24,246 (as of March 31, 1971) is hereby reappropriated to the Unappropriated Surplus of the General Fund.
