

AN ACT MAKING APPROPRIATIONS FOR THE CONSTRUCTION OF PORTABLE CLASSROOMS AND COLLATERAL EQUIPMENT, FOR THE PURCHASE OF SCHOOL BUSES, FOR THE PAY-PROMISE FUNDS OF THE DEPARTMENT OF EDUCATION, TO SIS THE COMMUNICATIONS COMMISSION, AND FOR THE OPERATION OF THE EXECUTIVE BRANCH OF THE GOVERNMENT OF GUAM FOR THE FISCAL YEAR ENDING JUNE 30, 1971.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any available
3 balance in the Unappropriated Surplus of the General Fund the
4 sum of Eight Hundred Sixteen Thousand Dollars (\$816,000) for the
5 construction of portable classrooms.

6 Section 2. There is hereby appropriated from any available
7 balance in the Unappropriated Surplus of the General Fund the
8 sum of Eighty Four Thousand Five Hundred Twenty Dollars
9 (\$84,520) for the renovation of Inarajan Elementary School and
10 Cafeteria.

11 Section 3. There is hereby appropriated from any available
12 balance in the Unappropriated Surplus of the General Fund the
13 sum of Three Hundred and Ten Thousand Dollars (\$310,000) to
14 construct 12 permanent Junior High School classrooms and rest-
15 room facilities and related collateral equipment.

16 Section 4. There is hereby appropriated from any available
17 funds in the Unappropriated Surplus of the General Fund the sum
18 of Three Hundred and Seventy Five Thousand Dollars (\$375,000) to
19 the Department of Public Works for the purchase of twenty-five
20 (25) school buses.

21 Section 5. The appropriations made by Sections 1, 2, 3 and
22 4, shall take effect July 1, 1971.

1 Section 6. There is hereby appropriated from any available
2 balance in the Unappropriated Surplus of the General Fund the
3 sum of Two Hundred Fifty Thousand Dollars (\$250,000) to the
4 Department of Education for the continued employment of the
5 para-professionals for fiscal year ending June 30, 1971.

6 Section 7. There is hereby appropriated from any available
7 balance in the Unappropriated Surplus of the General Fund the
8 sum of Twenty One Thousand Dollars (\$21,000) to the Telecommuni-
9 cations Commission for its operation for fiscal year ending
10 June 30, 1971.

11 Section 8. There is hereby appropriated from any available
12 balance in the Unappropriated Surplus of the General Fund the
13 sum of Five Million Dollars (\$5,000,000.00) for the operation
14 of the Executive Branch of the government of Guam for the fiscal
15 year ending June 30, 1971.
