AN ACT MAKING AN APPROPRIATION TO PERMIT THE TERRITORY OF GUAM TO PARTIC PATE IN THE FORTHCOMING SOUTH PACIFIC GAMES.

T. S. Tanaka

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of One Hundred Six Thousand Dollars (\$106,000) to provide for the participation by representatives of the territory of Guam in the ensuing South Pacific Games, and a written report covering the expenditures made for Guam's participation to be submitted to the Legislature not later than sixty (60) calendar days following the return to Guam of the participants.

Section 2. Twelve Thousand Four Hundred Forty-Five Dollars (\$12,445) of the appropriation made by Section 1 of this Act shall take effect upon approval thereof.

Section 3. Ninety-Three Thousand Five Hundred Fifty-Five Dollars (\$93,555) of the appropriation made by Section 1 of this Act shall take effect July 1, 1971.

Section 4. The appropriation made pursuant to Section 1 of this Act shall be subject to the composition of the delegation being comprised of not less than 85 per cent contestants.
