




AN ACT MAKING AN APPROPRIATION TO PERMIT  
THE TERRITORY OF GUAM TO PARTICIPATE IN  
THE FORTHCOMING SOUTH PACIFIC GAMES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any available  
3 funds in the Unappropriated Surplus of the General Fund the sum  
4 of One Hundred Six Thousand Dollars (\$106,000) to provide for  
5 the participation by representatives of the territory of Guam  
6 in the ensuing South Pacific Games, and a written report covering  
7 the expenditures made for Guam's participation to be submitted to  
8 the Legislature not later than sixty (60) calendar days follow-  
9 ing the return to Guam of the participants.

10 Section 2. Twelve Thousand Four Hundred Forty-Five Dollars  
11 (\$12,445) of the appropriation made by Section 1 of this Act  
12 shall take effect upon approval thereof.

13 Section 3. Ninety-Three Thousand Five Hundred Fifty-Five  
14 Dollars (\$93,555) of the appropriation made by Section 1 of this  
15 Act shall take effect July 1, 1971.

16 Section 4. The appropriation made pursuant to Section 1 of  
17 this Act shall be subject to the composition of the delegation  
18 being comprised of not less than 85 per cent contestants.
