BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. Section 21505.1 is hereby added to the Government Code of Guam to read as follows:

"Section 21505.1. Assistant General Manager for Engineering and Technical Services.

- (a) The General Manager, with the consent of the .

 Board, shall appoint an Assistant General Manager for Engineering and Technical Services, who shall serve at the pleasure of the General Manager and the Board.
- (b) The Assistant General Manager for Engineering and Technical Services shall be entitled to receive compensation to be determined by the General Manager with the approval of the Board.
- (c) Such Assistant General Manager shall devote his entire time to the business of the Authority, and shall have full charge and control, subject to the control of the General Manager and the Board, of all engineering and technical services of the Authority.
- (d) Such Assistant General Manager shall have such other duties as may be designated by the General Manager." Section 2. Section 21505.2 is hereby added to the Government Code of Guam to read as follows:

"Section 21505.2. Assistant General Manager for Administration and Fiscal Services.

(a) The General Manager, with the consent of the 1 Board, shall appoint an Assistant General Manager for 2 Administration and Fiscal Services, who shall serve 3 at the pleasure of the General Manager and the Board. 4 (b) The Assistant General Manager for Administra-5 tion and Fiscal Services shall be entitled to receive 6 7 compensation to be determined by the General Manager with the approval of the Board. 8 (c) Such Assistant General Manager shall devote 9 his entire time to the business of the Authority, and 10 shall have full charge and control, subject to the 11 control of the General Manager and the Board, of all 12 administration, accounting and fiscal services of the 13 14 Authority.
