AN ACT MAKING APPROPRIATIONS TO COMPLETE AND PROVIDE FACILITIES FOR A FOOTBALL FIELD AT JOHN F. KENNEDY SENIOR HIGH SCHOOL AND TO SUPPLEMENT THE APPROPRIATION MADE IN PUBLIC LAW 10-171 FOR THE CONSTRUC-TION AND IMPROVEMENT OF A DRAINAGE SYSTEM IN THE MUNICIPALITY OF DEDEDO.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Eighty Thousand Dollars (\$80,000) to provide for the construction of a football field with attendant bleachers, lights, and facilities at John F. Kennedy Senior High School.

Section 2. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Two Hundred Thousand Dollars (\$200,000) for the purpose of supplementing the appropriation made in Public Law 10-171 for the construction and improvement of a drainage system in the municipality of Dededo.

Section 3. This Act is an urgency measure.
