




CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR


This is to certify that Bill No. 226, "An Act making appropriations to complete and provide facilities for a football field at John F. Kennedy Senior High School and to supplement the appropriation made in Public Law 10-171 for the construction and improvement of a drainage system in the municipality of Dededo", which was heretofore passed and thereafter on May 8, 1971, returned to the Legislature without the approval of the Governor was, in accordance with the Organic Act of Guam, reconsidered by the Legislature and after such reconsideration the Legislature did on the 14th day of May, 1971, agree to pass said bill notwithstanding the objections of the Governor by a vote of more than two-thirds of all the members thereof, to wit: by a vote of 14 members.

1 AN ACT MAKING APPROPRIATIONS TO COMPLETE
AND PROVIDE FACILITIES FOR A FOOTBALL
FIELD AT JOHN F. KENNEDY SENIOR HIGH
SCHOOL AND TO SUPPLEMENT THE APPROPRIATION
MADE IN PUBLIC LAW 10-171 FOR THE CONSTRUC-
TION AND IMPROVEMENT OF A DRAINAGE SYSTEM
IN THE MUNICIPALITY OF DEDEDO.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any avail-
3 able funds in the Unappropriated Surplus of the General Fund the
4 sum of Eighty Thousand Dollars (\$80,000) to provide for the
5 construction of a football field with attendant bleachers,
6 lights, and facilities at John F. Kennedy Senior High School.

7 Section 2. There is hereby appropriated from any avail-
8 able funds in the Unappropriated Surplus of the General Fund the
9 sum of Two Hundred Thousand Dollars (\$200,000) for the purpose
10 of supplementing the appropriation made in Public Law 10-171
11 for the construction and improvement of a drainage system in
12 the municipality of Dededo.

13 Section 3. This Act is an urgency measure.
