



CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR

AN ACT TO AMEND SECTION 17350 OF THE GOVERNMENT  
CODE OF GUAM TO REDUCE THE PARKING SPACE REQUIRE-  
MENTS FOR COMMERCIAL PROPERTY IN THE MUNICIPALITY  
OF AGANA AND TO AMEND SUBPARAGRAPH (b) OF SECTION  
17105 OF SAID CODE TO PROVIDE FOR AIR, BUS, TAXI,  
AND AUTO RENTAL TERMINALS AS CONDITIONAL USES IN  
'R2' MULTIPLE DWELLING ZONES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. Subsection (f) of Section 17350 of the Government  
3 Code of Guam is hereby amended to read as follows:

4 "(f) For other commercial or industrial buildings,  
5 at least one (1) square foot of customer parking space  
6 for one (1) square foot of gross floor area, provided,  
7 however, that in the municipality of Agana, all areas  
8 zoned 'C' Commercial Zone, and 'M1' Light Industrial  
9 Zone at least one (1) square foot of customer parking  
10 space for two (2) square feet of gross floor area."

11 Section 2. Subparagraph (b) of Section 17105 of the  
12 Government Code of Guam is hereby amended to read as follows:

13 "(b) Conditional Uses.

- 14 1. Any conditional uses permitted in  
15 the 'R1' zone.
- 16 2. Health Clinics.
- 17 3. Utilities and public facilities.
- 18 4. Air, bus, taxi, auto, rental  
19 terminals.
- 20 5. Accessory uses and structures for  
21 the above."
