

CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR



AN ACT MAKING APPROPRIATIONS FOR THE IN-
STALLATION OF LIGHTS FOR THE PURPOSE OF
ILLUMINATING PLAZA DE ESPANA IN AGANA AND
FOR THE OPERATION OF THE MENTAL HEALTH
DIVISION OF THE GUAM MEMORIAL HOSPITAL.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any available
3 funds in the Unappropriated Surplus of the General Fund the sum
4 of Three Thousand Dollars (\$3,000) for the installation of
5 lights for the purpose of illuminating Plaza de Espana.

6 Section 2. There is hereby appropriated from any available
7 funds in the Unappropriated Surplus of the General Fund the sum
8 of Three Hundred Thousand Five Hundred and Five Dollars (\$300,505) *WY*
9 of ~~Three Hundred Ninety-Five Thousand Dollars (\$395,000)~~ for the
10 purpose of financing the operation of the Mental Health Division
of the Guam Memorial Hospital.
