AN ACT MAKING APPROPRIATIONS FOR THE IN-STALLATION OF LIGHTS FOR THE PURPOSE OF ILLUMINATING PLAZA DE ESPANA IN AGANA AND FOR THE OPERATION OF THE MENTAL HEALTH DIVISION OF THE GUAM MEMORIAL HOSPITAL.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum of Three Thousand Dollars (\$3,000) for the installation of lights for the purpose of illuminating Plaza de Espana.

Section 2. There is hereby appropriated from any available funds in the Unappropriated Surplus of the General Fund the sum Three Hundred Thousand Five Hundred and Five Dollars (\$300,505) of Three Hundred Ninety-Five Thousand Dollars (\$395,000) for the purpose of financing the operation of the Mental Health Division of the Guam Memorial Hospital.
