AN ACT MAKING APPROPRIATIONS TO FINANCE THE
COSTS OF INSTALLING SEWAGE CONNECTIONS TO
PRIVATE RESIDENTIAL HOMES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby appropriated from any available
3 funds in the Unappropriated Surplus of the General Fund the sum
4 of Seventy-Five Thousand Dollars (\$75,000) to the Public Utility
5 Agency Sewer Connection Fund for the purpose of advancing the
6 costs of sewer connection line installations to private resi-
7 dential homes, pursuant to the provisions of Section 9671 of the
8 Government Code of Guam.

9 Section 2. There is hereby appropriated from any available
10 funds in the Unappropriated Surplus of the General Fund the sum
11 of Two Hundred Seventy-Five Thousand Dollars (\$275,000) to the
12 Public Utility Agency Sewer Connection Fund to provide for the
13 connection of sewer lines without cost to private residences owned
14 and occupied by families certified by the Department of Public
15 Health and Social Services to be underprivileged according to
16 guidelines established by said Department.

1 Section 3. There is hereby authorized to be appropriated
2 from any available funds in the Unappropriated Surplus such
3 additional sums as may be necessary to finance the advancement
4 of the costs of sewer connection lines.
