AN ACT TO RENUMBER SECTIONS 1400 THROUGH 1415 OF THE GOVERNMENT CODE OF GUAM SECTIONS 1300 THROUGH 1315, TO RENUMBER SECTION 1300 OF SAID CODE SECTION 1400, TO AMEND SUBSECTION (a) OF SECTION 1314 OF SAID CODE AS RENUMBERED TO CONFINE PUNISHMENT FOR CONTEMPT OF THE LEGISLATURE TO FINE OR IMPRISONMENT AND TO RENUMBER CHAPTER V ENTITLED PACIFIC CONFERENCE OF LEGISLATORS AND SECTIONS 1400 AND 1401 OF SAID CODE, TO CHAPTER VII AND SECTIONS 1600 AND 1601.

BE IT EMACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. Sections 1400 through 1415 of Chapter IV of Title II of the Government Code of Guam as enacted by Public Law 11-9, Eleventh Guam Legislature, are hereby renumbered Sections 1300 through 1315.

Section 2. Section 1300 of the Government Code of Guam, entitled "Audit of Government Accounts and Financial Transactions," is hereby renumbered Section 1400.

Section 3. Subsection (a) of Section 1314 of the Government Code of Guam, as renumbered in Section 1 of this Act, is hereby amended to read as follows:

"(a) A person guilty of contempt under the provisions of this Code shall be fined not more than One Thousand Dollars (\$1,000) or imprisoned not more than thirty days or both."

Section 4. Chapter V of Title II of the Government Code of Guam entitled "Pacific Conference of Legislators", as enacted by Public Law 10-48, Tenth Guam Legislature, is hereby renumbered Chapter VII, and Sections 1400 and 1401 thereof are hereby renumbered Sections 1600 and 1601.
