



AN ACT MAKING APPROPRIATIONS FOR A PILOT  
PROJECT FOR THE CONSTRUCTION OF YOUTH CIVIC  
AUDITORIA IN THE MUNICIPALITIES OF DEDEDO,  
AGAT, TAMUNING, SINAJANA AND BARRIGADA, FOR  
THE OPERATION OF THE YOUTH CENTERS OF THE  
TERRITORY OF GUAM, AND FOR LAND ACQUISITION  
FOR PUBLIC HOUSING IN THE MUNICIPALITY OF  
YONA.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 ~~Section 1. There is hereby appropriated from any available~~  
3 ~~funds in the Unappropriated Surplus of the General Fund the~~  
4 ~~sum of One Hundred Twenty-Five Thousand Dollars (\$125,000) to~~  
5 ~~the Office of the Governor for a pilot project for the construc-~~  
6 ~~tion of youth civic auditoria in the municipalities of Dededo,~~  
7 ~~Agat, Tamuning, Sinajana and Barrigada.~~

8 Section 2. There is hereby appropriated from any available  
9 funds in the Unappropriated Surplus of the General Fund the  
10 sum of One Hundred Nine Thousand Six Hundred Thirty-Four Dollars  
11 (\$109,634) for the operation of the Youth Centers Programs  
12 under the Guam Youth and Recreation Commission.

1           Section 3. All monies received from the Federal Government  
2 for the purposes set forth in Sections 1 and 2 of this Act  
3 shall be deposited to the General Fund and be considered as  
4 contribution to said General Fund from the Federal Government.

5           Section 4. There is hereby appropriated from any available  
6 balance in the Unappropriated Surplus of the General Fund the  
7 sum of One Hundred Fifty Thousand Dollars (\$150,000) for land  
8 acquisition for public housing in the municipality of Yona.
