AN ACT TO AMEND SECTION 25327 (c) OF THE GOVERNMENT CODE OF GUAM TO PERMIT MANUFACTURERS OF DRAUGHT BEER AND FERMENTED BEVERAGES TO RENT, LEASE, SELL OR LEND EQUIPMENT FOR THE REFRIGERATION AND DISPENSING THEREOF.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. Section 25327 (c) of the Government Code of

Guam is hereby amended to read as follows:

"Section 25327. Restrictions on interests and transactions between licenses. A manufacturer, agent or wholesaler of alcoholic beverages or any officer, director or agent of such persons shall not.

- (a) Hold, directly or indirectly, the ownership of any interest in any on-sale or off-sale license.
- (b) Furnish, give or lend, directly or indirectly, any money or other thing of value to, nor guarantee the payment of any loan or the fullfillment of any financial obligation of, any person engaged in operating, owning or maintaining any on-sale or off-sale premises.
- (c) Furnish, give, lend, rent, or sell directly or indirectly, any equipment, fixtures or supplies other than alcoholic beverages, draught beer dispensers, or indoor signs in accordance with regulations prescribed by the Board, to any person engaged in operating, owning or maintaining any on-sale or off-sale premises.
- (d) Own, directly or indirectly, any interest in the business, furniture, fixtures except indoor signs, or lease of any premises operated or maintained under an on-sale or off-sale license or own, directly or indirectly, any

interest in land upon which on-sale or off-sale premises 1 are maintained unless the holding of such interest is permitted in accordance with regulations of the Board. 3 4 (e) Deliver, directly or indirectly, the possession of any alcoholic beverages to any on-sale or off-sale 5 licensee under an agreement or consignment whereby title 6 7 to such alcoholic beverages is retained by the seller or 8 whereby such licensee receiving such alcoholic beverages has the right at any time prior to sale to relinquish possession to or return them to the original seller. 10 11 (f) Give, directly or indirectly, to any on-sale or 12 off-sale licensee or any other person any alcoholic 13 beverages as free goods as a part of any sale or trans-14 action involving alcoholic beverages. 15 (g) Give secret rebates or make any secret concessions 16 to any on-sale or off-sale licensee. 17 (h) Give or furnish, directly or indirectly, to 18 any agent or employee of an on-sale or off-sale licensee, 19 anything of value for the purpose or with the intent to 20 solicit, acquire or obtain the help or assistance of such 21 agent or employee to encourage or promote either the 22 purchase or the sale of the alcoholic beverages sold or 23 manufactured by the licensee giving or furnishing him any 24 such thing of value. 25 (i) Knowingly discriminate, directly or indirectly, 26 in the same trading area, in the price or any such brand 27 of alcoholic beverages sold to different retail licensees 28 purchasing under like terms and conditions. 29 (j) Credit or compensate an on-sale or off-sale 30 licensee for advertising display or distribution service 31 in connection with the advertising and sale of alcoholic 32 beverages. - 2 -
