

CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR



AN ACT AUTHORIZING AN APPROPRIATION TO
DEFRAY THE COST OF INSTALLATION OF A
WATERLINE COMMENCING FROM THE U.S.
NAVY HIGH PRESSURE LINE TO LOTS NOS.
401-R-2 AND 402-10-11-1, AND CONSTRU-
TION OF A RESERVOIR LOCATED IN THE
MUNICIPALITY OF AGAT.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. There is hereby authorized to be appropriated
3 the sum of Three Hundred Fifty Thousand Dollars (\$350,000.00)
4 to defray the cost of installation of a waterline commencing
5 from the U.S. Navy High Pressure Line to Lots Nos. 401-R-2 and
6 402-10-11-1, and construction of a reservoir located in the
7 municipality of Agat.
