AN ACT TO AMEND SECTION 4106 OF THE GOVERNMENT CODE OF GUAM RELATIVE TO POSITIONS IN THE UNCLASSIFIED SERVICES AND AUTHORIZING AN APPROPRIATION.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. Section 4106 of the Government Code of Guam is hereby amended to read as follows:

"Section 4106. Unclassified service. The positions set forth herein shall constitute the unclassified service and are hereby given basic annual compensation as follows:
